PLEASE NOTE THE FOLLOWING:

- The first 48 hours of on the job training (OJT) will be a probationary period.
- Assignments to a vacancy on the master schedule will be made by total hours of service to the Patrol, should more than one officer be requesting reassignment to a specific position.
- Uniforms and all accessories issued to you are the property of the Sun City Summerlin Community Association, Inc. (SCSCAI), and must be returned when you terminate your membership in the Patrol for any reason.
- You will be subject to and governed by the Patrol's Membership Application, Membership Agreement, Constitution and By-laws, as well as its Policies and Procedures Manual.
- Your work assignment will be within the Sun City Summerlin area.

Ideally, applicants should attend a recruit training class prior to beginning training and must attend one prior to completion of training.



SUN CITY SUMMERLIN SECURITY PATROL

I UNDERSTAND THAT AS A MEMBER OF THE SECURITY PATROL:

- I will be covered **while on duty** by a blanket insurance policy and that my personal liability will in no way be affected.
- I agree to volunteer a minimum of 4 hours a week or 100 hours per Security Patrol year (i.e.: July 1 – June 30).
- I agree to complete my training within three months of the date I join the Patrol.
- I agree NOT TO SMOKE in the patrol cars, information centers or office.
- I agree NOT TO EAT or DRINK anything other than bottled water in the patrol cars.
- I agree to abstain from using alcohol for at least 12 hours prior to my duty assignment and while on duty.
- I agree to comply in all respects with the Patrol's Membership Application, Membership Agreement, Constitution and By-Laws, as well as its Policies and Procedures Manual.

I UNDERSTAND THAT SHOULD MY CONDUCT BE UNBECOMING OR DEEMED DETRIMENTAL OR INJURIOUS TO THE ORGANIZATION THAT MY MEMBERSHIP CAN BE SUSPENDED AND I WILL BE HELD PERSONALLY LIABLE FOR MY ACTIONS. MY SIGNATURE CONSTITUTES MY UNDERSTANDING OF THIS STATEMENT.
